NOTIFICATION

Following is in connection with Summer term – 2023 registration:

1. List of courses likely to be offered in Summer term – 2023 can be found at:

2. All UG students (except for BT-BS batch of Y22) are eligible for applying for Summer course if:

- a) They are graduating at the end of Summer Term 2023.
- b) They are under Academic Probation/Warning.
- c) They have a failed backlog in the course.
- d) They have a fresh backlog in the course.
- e) They wish to do course in advance.

3. PG students may register for PG courses if they have a failed or a fresh backlog.

4. All PG students will register for Thesis credits in the Summer Term.

5. UG students can register for up to 3 courses not exceeding 27 credits.

6. Number of thesis credits that PG/Dual degree students can register for is Zero to 18 credits. Zero credits are for students who have submitted their thesis and are waiting for defence or have completed their credit requirements. If, however, a student is likely to submit his/her thesis within two weeks from the commencement of classes, he/she need not register in the summer term.

7. PG/Dual degree students registering for courses only or course + thesis credits can register for Zero credits to 20 credits. Zero credit will be allowed for students registering for Zero credit courses. 20 Credits account for two 10-credit course or one 11-credit plus one 9-credit course/9-thesis credits.

8. The Summer registration will open for all UG and PG students on the [Pingala portal](#) on May 12, 2023, at 3:00 pm.

9. The Summer registration will close on May 14, 2023, at 5:00pm.

10. You can request for a maximum of 6 courses in the application form.

11. Please request courses without timetable clashes. You are requested to check the clashes manually. Clashes will not be checked from our end.

12. You are advised to provide genuine reasons for selecting the courses, failing which disciplinary action will be initiated.

13. Please do not approach the instructor DU(P)GC with course requests.

14. Registration in courses will be subject to eligibility as stated above.

15. Chairperson SU(P)GC is the final approving authority for registration.

16. Course allotment will be released on May 16, 2023, by 3pm.

17. If you fail to give your choice(s) of courses during May 12-14, 2023, you may register late for the available courses on May 20, 2023. However, by that time some courses may have no vacancy.

18. The course(s) allotted to you will be recorded as finally registered courses under your academic registration.

19. If you have been allotted course(s) but you are not keen to register for the same you must request to drop the same by sending email to aryak@iitk.ac.in latest by 10:00 AM on May 17, 2023. The subject of the email should be "SUMMER COURSE DROP" and the course number should be mentioned in the email.

If you fail to send email to drop the course by the given deadline, you will be considered to be registered in the allotted course and hence, will be liable to pay the academic registration fee. In addition, since you will be considered to be registered in the course(s), you will be awarded a grade as per the course policy.

20. Students registered in the Summer Term 2023 are required to pay the summer registration fee on May 17, 2023.
