The following issues were discussed in MSWC meeting held on 9th Jan'17:

1. Ratification of minutes of MSWC meeting held on 9th Jan'17

There was no correction in the draft minutes, and minutes have been uploaded on the website.

2. Appointment of election officers

Two election officers are required to conduct the election for next MSWC. Based on the received responses and seniority, following residents have been appointed as election officer:

Now, the appointed election officers are requested to initiate the election process as soon as possible.

3. Discussion over utilization of the allocated budget for celebrating SBRA day 'Samanvay'

As you all know, an amount of Rs. 80,000/- was allocated to celebrate the SBRA day. However, an amount of around Rs. 60,000 has been spent to celebrate the SBRA day 'Samanvay'. The details of the amount spent under different heads, will be mailed soon to all residents.

4. Case of Mrs. Ranu Pal (Residents of F-6)

With the permission of Warden, SBRA, the case of Mrs. Ranu Pal was discussed. Since, Mrs. Ranupal is staying without spouse and it is not possible for her spouse to maintain 75% occupancy in SBRA (as agreed by Mrs. Ranu Pal in last MSWC meeting), she was asked to leave the SBRA. However, she took her case to Deputy Director and DOSA for further discussion and consideration. The MSWC was also asked by DOSA to opine on the matter. Now, considering the suggestions given by DOSA on the matter, the MSWC requests Mrs. Ranu Pal to vacate the SBRA at the earliest. However,

5. Proposal of converting one of the activity center's rooms as guest room



However, before taking the final decision, the matter will be discussed again in next MSWC meeting.

6. Status of implementation of decisions taken by MSWC in previous meetings

- a) The Application for the static security guard in old SBRA has been reached to the security head via DD. Final decision on the application will be taken in next meeting of the concern authorities.
- b) Estimate for lighting facility at new SBRA's badminton court and for constructing stage at new SBRA is under the process of approval.
- c) The application for the installing notice boards at new SBRA has been processed.
- d) The application for the street lights for M block has been reprocessed with the required changes (asked by IWD).
- e) The application for the maintenance of the main road of old SBRA has also been processed.
- f) The application for the installation of mosquito mesh in old SBRA will be processed soon.
