3. The rates quoted should be inclusive of GST, no other tax is payable except GST.
4. Security @ 7.50% shall be deducted from the bills which shall be released on successful completion of defect liability period of six months.
5. Earnest Money of **Rs.1,917/-** is to be submitted in the form of FDR pledged in favour of the Director, IIT Kanpur alongwith the quotation. The earnest money of the unsuccessful quotationers will be returned within one month's time. (Estimated cost **Rs.95,829.00**)
