**The terms and conditions of the quotation are as under:**

1. The quotations should be submitted
2. in a properly sealed envelop, addressed to the undersigned. The enquiry nos. and date should invariably quoted on the top of the envelop.
3. The time allowed for carrying out the above noted work is 21(Twenty One) Days.
4. The rates quoted should be exclusive of GST, no other tax is payable except GST. GST shall be applicable as per Govt. norms..
5. Security @ 6% shall be deducted from the bills which shall be released on successful completion of defect liability period of six months.
6. The estimated cost of quotation is **Rs.49525/-**. The required earnest money of **Rs. 1486/-** is to be submitted in the form of FDR pledged in favour of the Director, IIT Kanpur alongwith the quotation. The earnest money of the unsuccessful quotationers will be returned within one month's time.
7. The quotations shall remain valid for 90 days from the date of opening.
8. Income tax will be recovered as per notification of Government from the bill and the amount so recovered will be deposited in the State Bank of India at the credit of the firm.
9. The earnest money/Security deposit will be regulated as per the norms of C.P.W.D.
