Sub. Purchase of the Battery Bank

We are interested in purchasing Battery Bank (Qty-80 Quantity may vary), having following configuration. Please send sealed quotation along with technical specs & documents for the same. The envelope must be inscribed with "**Quotation for Battery Bank**".

Battery Capacity	130 Ah or more
Total back up time	At least 1/2 hour at full load.
Warranty	5 years on-site comprehensive warranty free replacement of any defective battery with new battery of same make and model. The warranty must be provided by the OEM (not by the vendor but vendor will bear the responsibility of replacing the batteries) Warranty should include labor, component, transport and other charges. **
Body material	Container material to be of low permeability, anti-corrosive. Flame/fire retardant of grade V0 (will be preferred).
UPS Details (For Reference Purpose)	One 80 KVA UPS will have battery bank of 40 Batteries. One 60 KVA UPS will have battery bank of 40 Batteries (These can be quoted separately)

Optional but mandatory to quote:

Buy Back	We have 200 Quanta Batteries (purchased in July 2014) to be bought back against this purchase with the following specification: 120 batteries of 130AH and 80 batteries of 100AH.

** Response time for engineer to visit the site should be always on the same day, however if the information is delivered after 3PM, engineer can visit the site on the next day.

NOTE:

1. Existing Battery bank racks are already present. Installation will be done by the vendor end.
2. Preference will be given to only those vendors who have Service/ Repairing

center stationed at Kanpur (Single point of contact in Kanpur for any service related issues).

3. No Call Locking will be entertained (in/out stationed). If at all it is required then it will be performed by Vendor.
4. Testing of the product onsite is mandatory.
5. Reporting time should not be more than 2 hours.
6. Resolving time should not be more than 1 day.

Terms & Conditions:

- One can quote as many options as possible. There is no limit. Provide the minimum required information in the following format.

- All quotation must reach undersigned on or before 16th March, 2017 before 1500 hrs.
- All quotations must contain complete technical details of the product.
- Quotation must be valid for 60 days.
- All prices are to be FOR IIT Kanpur.
- Delivery period must be within 4 weeks from purchase order date.
- You may quote in US dollars or any other foreign currency. The prices quoted need to be FOB, only. The payment shall be made through LC in favor of principal OR wire transfer, as per the institute rules. In this case, the validity of quotation should be 90 days.
- The institute is exempted for payment of Excise duty under notification No. 10/97 & partially custom duty (@5.15%), under notification 51/96 and a road permit will be provided, if applicable. The Concessional Form 'C/D' have been abolished w. e. f. Apr 01, 2007.
- Our standard payment terms and conditions is 90% on installation and 10% after inspection and approval.
- The Penalty @1% per week or part thereof subject to max 10% of the delivery price will be deducted from the balance payment, if supply is not completed within aforesaid delivery period.
